

OLI Token - Rules of the Game

This Document

This Document describes the rules used around the “OLI Token”.

This Document can be changed at any time as a result of a specific decision process described in this document.

This Document will be kept up to date after each decision affecting the rules laid out here.

Characters and Roles

- Sasha, Hero Oleksandra Oliynykova, Tennis Player
- Denis Denis Oliynykov, Career Manager, Financial Manager
- Team Oleksandra & Denis are the core team.
- Holders, Players Owners of OLI tokens
- The Patriarchs A decision-making body, group of people selected by certain rules (see below).

Scope

While the OLI Game can potentially become much larger in the future, the scope of this document and the OLI token are Sasha’s tennis career.

Goal of the OLI Game

The goal of the OLI Game in the incarnation described in this document is to advance Sasha’s tennis career to the point where she plays major tournaments and has a high WTA rank.

The OLI Token

OLI Token is the SLP Token on Bitcoin Cash (BCH) blockchain with ID

OLI Tokens represent ownership of certain aspects of Sasha’s tennis career as described in this document.

1 Million OLI tokens had been initially created, 840,320 have been burned, so there are 159,680 OLI in circulation, of which

- 5,002.47527 OLI will be kept in OLI Reserve for future marketing initiatives, bonuses etc.
- 154,677.52473 OLI are held by the holders

No more tokens can be created.

Income

Excluded Income

Income from activities outside of the OLI Game are not distributed and remain in possession of whoever earned it. Excluded income specifically includes:

- **Special tournaments:**
 - Olympic Games;
 - Fed Cup & other national team competitions;

- Charity matches & tournaments;
- Any tournament prizes (beyond prize money) received in-kind – jewelry, fine arts, gadgets, etc.
- **Certain advertising & endorsement deals, media appearances:**
 - Proceeds from non-tennis media activities (like reality shows, movies, etc.);
 - Proceeds from books, scenarios, movie rights;
 - Technical partnerships with supply received in-kind (rackets, strings, etc.);
- **General:**
 - Proceeds received from personal business projects, investments & activities non-related to the game.

OLI Game Income

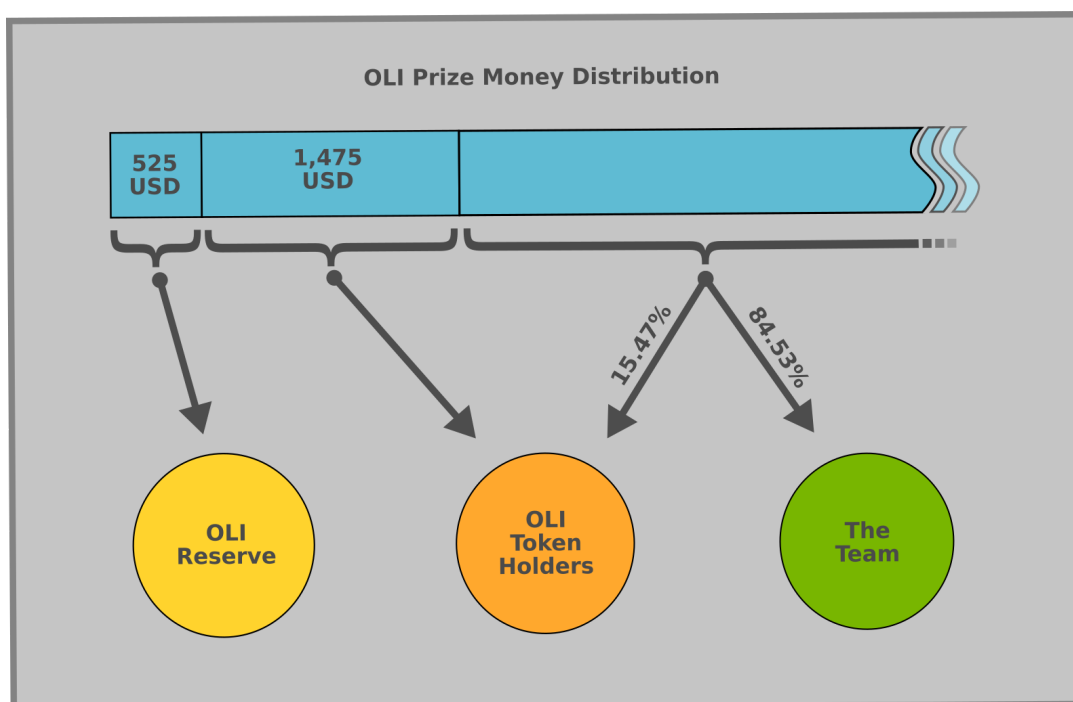
All income earned through the activities of the OLI Game except Excluded Income are distributed according to the Income Distribution Scheme. This income includes but is not limited to tournaments (such as licensed by WTA, ITF, UTR, national tennis federations), exhibition matches, private tournaments, fixed payment events (such as league matches), and tennis-related advertising and endorsements.

Income Distribution Scheme

Once OLI Game Income is received, the following algorithm is executed.

1. Prize money is received by Sasha
2. Any income taxes Sasha has to pay are subtracted (if not already done by tournament operators). Rest is called “remainder”
3. $\min(\text{remainder}, 525 \text{ USD})$ is given to reserve. Rest is called “remainder”
4. Any remainder less than 10 USD is also given to reserve
5. $\min(\text{remainder}, 1475 \text{ USD})$ is distributed to Holders. Rest is called “remainder”
6. Any remainder less than 10 USD is also distributed to Holders
7. 15.47% of remainder are distributed to Holders. Rest is called “remainder”
8. Any remainder less than 10 USD is also distributed to Holders
9. The remainder is distributed to the team (or remains in possession of the team).

The following diagram is for illustration purposes:



Funds Handling & Wallets

The OLI Reserve

The OLI Reserve serves as a depository for funds aimed to pay future costs of practices, travels, equipment purchases, etc. in line with the goals of the OLI Game. If the goals of the OLI Game become unrealistic, for example due to a "game over" scenario, and no agreement can be reached on a change of the goals, the reserve must be distributed to Holders.

The following transactions (and only those) can occur to/from the OLI Reserve:

- Incoming from Master Wallet
 - Funds from Income distribution that go "to reserve"
 - Other game-related proceeds
- Incoming from Supporters
 - Support funds received
- Outgoing to Master Wallet
 - 2500 USD at the beginning of each calendar month for regular expenses.
 - A one-time 7500 USD fund for emergencies and unexpected needs. Any usage of the fund should result in a simple accounting report and a top-up to refill the emergency fund.
- Outgoing to Holders (may be routed through intermediary wallet for technical reasons)
 - If a decision is made to distribute all or part of OLI Reserve to Holders

OLI Reserve Wallets

- BCH in OLI Reserve are generally kept in a "3 of 4" multisig with 2 keys owned by the Financial Manager and 2 more by other patriarchs.
- OLI tokens in OLI Reserve are kept in a separate wallet controlled by Financial Manager. BCH in this wallet (for example from income payouts to token holders) are moved to the Multisig Reserve wallet whenever their value exceeds 500 USD.

OLI Master Wallet

The master wallet receiving address for funds coming from OLI Reserve is
bitcoincash:qpkxcexsk3y9wn2nx9nqnyg57lg3dawmq4knhkhhn

The Master wallet is the main operational wallet. Used as a source/destination of the project regular (routine) operations such as initial handling of OLI Game Income, Fiat Top-ups & Withdrawals, and management of emergency funds. It is controlled by the Financial Manager.

Fiat Top-ups & Withdrawals

For the project-related top-ups (buying BCH with fiat) or withdrawals (selling BCH for fiat) an internal clearing is used wherever it is possible (reasonable). Otherwise, funds are exchanged by the most secure, low-cost and fast way available.

Decision Making and Governance

The central decision-making body is a group called The Patriarchs.

There are 5 Patriarch spots currently filled with the following individuals:

- Sasha
- Denis
- Paul

- Emergent_reasons
- Molecular

Making Proposals and voting

Any Holder may publicly suggest a proposal. If the proposal is generally supported by the community (holders and interested observers) during the open discussion, it will be voted on by the Patriarchs.

Patriarchs can also make internal proposals that are not discussed publicly.

Proposals are accepted if 5 patriarchs vote in favor of it, otherwise rejected.

If a Patriarch has not voted within 48 hours after voting begins, their vote is counted as approval.

Patriarch removal / addition

- Patriarch assignment does not generally expire.
- Patriarch may resign by their own will.
- Patriarch can be removed by a 4/0 vote of the other patriarchs in the following cases:
 - Does not participate in voting for 3 consecutive votings
 - Is the rejecting patriarch in 3 consecutive votings with result 4/1
 - Confirmed to have directly and purposefully harmed the project
- If not all patriarch spots are filled, a new patriarch is elected by approval of all patriarchs

Transparency and Reporting

Financial Manager publishes in a timely manner the following information:

- Transactions on OLI Reserve Wallet (Date, BCH Amount, Purpose, and if appropriate, Fiat Amount, Calculated Exchange Rate)
- Received OLI Game Income with Date, BCH Amount, Description, flag whether it will be distributed, and if appropriate, Fiat Amount, Calculated Exchange Rate
- Information about Income Distribution payouts to holders
- Balance of emergency funds in master wallet (at least monthly)

BCH Promotion

Hero and Team make a commitment to exclusively promote Bitcoin Cash (BCH) during Game Activities.

Promotion Facilities

The Game promotion facilities include:

- Sasha's garments, bags, accessories etc worn or used during tennis matches, practices, public appearances as a part of the Game etc.
- Sasha's Game-related media appearances - interviews, press conferences, documentaries etc.
- Social media accounts: Twitter, Instagram, Youtube, TikTok etc.
- The OliCrypto website.
- The Bitcoin Cash Van exterior & interior.
- Anything publicly visible (media appearances or publications, products,...) that is directly connected to the OLI Game

Exceptions to exclusivity:

- Paid sponsorships / ads / endorsements approved as part of the OLI Game (with proceeds distributed among Holders according to the rules laid out in this document).

- Tennis rackets, strings & accessories manufacturers that support the Hero “in-kind” (by providing rackets, strings etc.)
- Promotions facilitated by tournament(s) Sasha participates, so mandatory by tournament conditions (requirements).
- Promotions of tournaments or tennis associations themselves.
- Any other cases, explicitly pre-approved according to the rules laid out in this document.
